## Eligibility for Bloodline Cleansing Basic Requirements Ground Rules and Exhortation

Bloodline cleansing is not magic or sorcery or divination. Those are all counterfeits of God's true power. Bloodline cleansing is Heaven's legal way to remove the demonic authority that has ruled over your family bloodlines through repetitive, habitual, generational sins. It is all done supernaturally. **Our weapon and gift is repentance.**

There may be sins in the form of habits, behaviors, beliefs, or traditions in your family bloodline that have been handed down over the years. No one ever repented of these things, instead they became accepted as normal. Wrong beliefs are connected to the hindrances that can hinder you or your family from fulfilling Divine destiny.

Your willingness to believe what in the power of what God said and what Jesus has done will turn things around. As you repent (change your thinking) and take on the Truth of God's word, your words will remove curses off your ancestry, even as they invite God's redemption *and* the generational blessings into your bloodline.

*Do you qualify for bloodline cleansing? The basic requirements are below.*

1. You must be born [again] from above (John 3:3).
2. You must have been baptized as an adult. You must know and recognize what the shed Blood of Yeshua did for you.
3. Bring an offering. While the Administrator will receive it and pray over it, this is not payment to the individuals that are conducting the bloodline cleanse.

This is a thanksgiving offering to God, a testimony of your release of faith in the Courts. You are saying that you believe and expect the power of God's Word to perform on your behalf. Your offering is presented as a memorial before the Lord through this ministry. It will come before the Lord as a sweet sacrifice.

4. We believe that the Bible makes it clear **that everyone that belongs to Jesus can see into the spiritual realm.** It's an act of faith, a choice to believe and expect. Some may argue that they never see anything, or hear anything from God. But Jesus makes it clear that our eyes are blessed to see. Our ears are blessed to hear. Receive this BY FAITH as YOUR TRUTH.
  - Tell yourself: *"I choose to believe that when I ask Holy Spirit to reveal the Truth about me, He will. If seeing or hearing has not come easily for me, He will show me what to do. I will ask Him...and He will lead me.*
  - *I choose to believe what God says.*
  - *I choose to hear (believe) that my breakthrough time has come.*
  - *I choose to believe what I hear God's word say to me.*

Jesus points out that you have ears, so you can hear, and eyes to see what He wants you to see. How you measure His truth determines the results you will choose to expect. (Mark 4:23-24, Luke 8:17-18). *"But blessed are your eyes, for they see: and your ears, for they hear."* Matthew 13:16

Through Holy Spirit, we activate our faith in the supernatural power of God. He then leads and guides us into the ways of righteousness. Get ready to receive the fulfillment and manifestation of His promises to you in your generation.



## San Jose Global Reformers Hub Foundational Principles

### Role of The Father As Judge

God is a loving, generous Father, and He delights and takes pleasure in His children. It is always the Father's heart to bless His children. We can approach Him as He sits on His Throne of Grace (Hebrews 4:16), without any kind of formal protocol. He is our Abba Father, and as such, grants us mercy and help in times of need.

When we have a case to bring to the courts of Heaven, it is a different scenario. This is when we meet our Creator God, the One that is the perfect, righteous, sovereign, just Judge of all. In the Courts of Heaven, as Judge of all, He must have a proper legal reason presented to Him to be able to render righteous verdicts on behalf of His own. We make our court appearance to provide Him with those necessary authorizations.

The religious belief that the sovereignty of God enables Him to do whatever He wants to do, is **not true**. Sovereignty means that He has supreme power and authority to rule as Judge over His domain. He is ruler over His own Word and established laws. A righteous Judge upholds legal precedence. He does not just do what He wants. He does what He says He will do, according to the legal precedents that He established.

This means that whenever we, His people, speak His Words and obey His commands, He is legally obligated and allowed to rule in our favor. The commands that we are obeying in the Courts of Heaven include confessing our own sins, and repenting for the sins of our bloodlines and self. While it overrides the voice of the accuser, it also reestablishes God's set authority in the earth.

### Role of The Accuser

Revelation 12:10 tells us that Satan is the accuser of the brethren. Strong's Concordance tells us the word *Accuser* comes from the Greek word *kategoreo*<sup>1</sup>, which is defined as a complainant at law, against one in the assembly; one who brings a lawsuit. Yeshua refers to Him as the *antidikos*<sup>2</sup>, the adversary that delivers you to the judge if you are not quick to agree. Yeshua is not saying to enter into agreement with the adversary. He is telling us to be quick to confess and repent of the accusation before God, thus clearing your name in the sight of the Judge!

The adversary roams throughout the earth seeking legal reasons to bring accusations against us, demanding that we be put on trial (1 Peter 5:8, Luke 22:31). This is what Yeshua warned Peter about. The adversary "has *desired* you, that he may sift you as wheat". That word *desire* comes from a Greek word, "*exaiteo*", which is defined as "to demand (for trial)". Wow.

The present-day *Miranda Rights*<sup>3</sup> give the warning, "*Anything you say can and will be used against you in a court of law.*" Those words did not originate with man, they are derived from the spiritual law of first mention found in Genesis, "and God said, and it was so." "Let Us make man in Our image, after Our likeness [*giving mankind the same creative power of words that We use.*]"

In the spirit realm, our spoken words set the course for actions and reactions. Whenever we speak words of doubt, unbelief, defeat, sickness, poverty, etcetera, we are speaking in agreement with the adversary. We must correct that by speaking the Words of our Father. The holy scriptures provide us with words for every situation. These are the words that we must speak. Otherwise the earthly, sensual, devilish words (and corresponding actions) will be used against us in the court of Heaven.

How often have you experienced delays and blocks to promises from God? What part of your fulfilled destiny is on hold? What have you, your business, family or ministry have yet to receive from the finished work of the Lord Jesus on the Cross? Why the delay? It may be because something legal is being used by the devil as a claim to resist or deny you from the release.

The righteous Words of God, when spoken in the Court, will overturn the adversary's claim. Every. Single. Time.

## **Role of Jesus Christ And The Redeemed**

When we made the decision to confess Jesus as Lord, and believe in our hearts that God raised Him from the dead, we were born from above (Romans 10:9-10, 13, John 3:3-9). Being born from above means that we are redeemed by the Blood of Jesus Christ. We are restored to right relationship with our Abba Father, just as it was in the beginning when He first made man. We can once again receive the lavish love of our loving, Heavenly Father.

Because of His love for us, Yeshua was obedient to the Father, and made the ultimate sacrifice for us. Jesus has the right and authority to mediate into place, everything that is legally ours. He has this right by virtue of His sacrifice and finished work on the Cross. This means that we, the redeemed, can have everything restored that was legally bought and paid for by the His Blood sacrifice. This includes position, authority, power, the ability to prosper, and dominion.

As the Mediator on our behalf, the Blood of Yeshua Himself answers the accusations that our adversary brings against us in the courts. Our part is to repent and to apply the Blood and activate the power of the finished work which He bought for us.

***Colossians 2:13-14 "And you, being dead in your trespasses and the uncircumcision of your flesh, He has made alive together with Him, having forgiven you all trespasses, having wiped out the handwriting of requirements that was against us, which was contrary to us. And He has taken it out of the way, having nailed it to the Cross."***

Yeshua (Jesus) took away the power of all the adversary's accusations.

**Here is Truth:** The accuser has no rebuttal for the Blood.

## **Role of The Registered Ekklesia in the Earth**

Apostle Robert Henderson (2014), shares in his book, *Operating in the Courts of Heaven*, how "we are told that the Church of the firstborn is registered in Heaven for operation in the courts of the Lord...we, as the Church/Ecclesia, have been granted a voice in the court system of Heaven." (pg. 149). He's quoting from Hebrews 12:23.

James 4:6-7 tells us, "...*God resists the proud, but gives grace to the humble. Therefore submit to God. Resist the devil and he will flee from you.*" Whenever we have humbled ourselves in God's sight, rebuked the devil, but the expected results do not manifest, it's because he still has a legal right to withstand us.

In the same book, Robert Henderson (2014) says: “Any lack of the Kingdom being manifest is because of a legal issue...God is not withholding from us. If there is a lack of manifestation of Kingdom purpose, it is because we have yet to grant the Father the legal right to fulfill His passion toward us...something legal is standing in the way of the answer...The accuser of the brethren is speaking against us. The answer to this is to learn and agree with the voices in the court of Heaven.” (p. 77)

We are not ignorant of the adversary’s devices. As the Ekklesia, we do not panic or give way to a sense of hopelessness or futility. When we recognize an enemy stronghold has been erected, we seek Holy Spirit to learn if there is a case against us. We know that we cannot legally remove the adversary in the spirit, until we first remove his cause for the claim. So, we prepare for Court.

We know that it is time to activate the power of repentance to make way for the remedy that leads to our breakthrough. We remember that Yeshua instructed us to agree with our adversary quickly.<sup>4</sup> Confessing our sins, removing transgressions and addressing iniquity through bloodline cleansing is oftentimes part of that process.

As the Ekklesia, we are given the honor, power and authority to enter the courts and get the adversary’s legal rights removed, receive, and then execute into place the verdict rendered on our behalf by the Judge. We know that along with Yeshua, there are other voices in the court that testify on our behalf. These voices include the cloud of witnesses, the angels, our offerings, and our repentance (Hebrews 12:22-24). “*For the testimony of Jesus is the spirit of prophecy,*” Revelation 19:10.

We are ambassadors and citizens of God’s Kingdom, as well as stewards of His finished work here on the earth. We are also kings and priests in the earth. When we receive a verdict from the just Judge, we can execute that word as a royal decree. We have designated measures of authority and responsibility to renounce and rebuke every form of demonic activity within our metron (2 Corinthians 10:13). We are activating the power of the royal verdict.

When Yeshua testifies on our behalf in the courts of Heaven, it can then become prophecy in the mouths of the ekklesia in the earth. What are we prophesying? That which is written in the books of Heaven.

As we prophesy, declare, and decree the Words of God, we actively agree with and release the same testimony that Yeshua is releasing in Heaven. We make degrees that carry the authority of Heaven’s court. We act, in effect, as “Court officers,” along with the angels assigned to hear and carry out the Word and pleasure of the Lord (Psalm 103:20-21).

In accordance with the books written about us, our lives and everything that pertains to life and godliness<sup>5</sup>, we activate the power of Matthew 6:10, “*Thy kingdom come. Thy will be done in earth, as it is in heaven.*” If it is not written in God’s books, we want it stricken from the record for ourselves, our fathers’ and the rest of our generations, just as He did for Nehemiah (Neh. 1:5-7).

If it is meant to fulfill His pleasure, and the destiny He has assigned to us, we want it to manifest in the earth. We have that honor and ability to discover the will of our Father, and to work alongside Holy Spirit, the angels and all of Heaven to accomplish His pleasure and desire in the earth. This is our legal right as God’s registered ekklesia (Hebrews 12:23).

We are His legislative, governmental, and judicial people, here in the earth to carry out the finished work of the cross. Through us, Yeshua’s reward will be fully manifested. Hallelujah!

## San Jose Global Reformers Hub Basic Bloodline Cleanse Team

Our team consists of (1) **Administrator**, a team of **Seers** (1 - 6), and **You**. The roles of everyone are clearly delineated for this activation.

**Administrator:** The designated individual that will lead you through the cleansing. This is the person that seeks for interpretation and instruction of all that Holy Spirit reveals through the seers and/or you.

**Seers:** The designated individuals that seek, see and hear in the realm in the spirit for the problematic areas and causes. The seer(s) will typically be allowed to see a picture, hear a word or get an impression of the activity in the spirit realm.

**You:** The primary task that you will perform is repentance for yourself. Part of your preparation is to repent in general *before* your appointment. Make it your job and responsibility to stir up your faith and follow the instructions you are given.

It is good to know the names of your grandparents on both sides of the family when possible. It is also good to reveal if you have more than one set of grandparents (second marriages, etc.) and to know those names as well. If you don't, that's fine, but it can be helpful.

**Please Note:** You **Do NOT** have to go digging into all the family history or scandals, it is not necessary to air all your ancestral scandal or dirty laundry. If the Holy Spirit deems it to be necessary, then He will lead us to confront a specific area during our time together. Holy Spirit knows EXACTLY where He wants to lead us, and that is the only place that we will go.

This is all by faith and by direction of Holy Spirit. He leads and guides us. We ask, and keep asking.

We will close all existing portals/doorways/gateways that we know about. These are the areas where we have regularly accessed demonic trades and technology (skillsets, words, emotions).

We go through only one Door – Yeshua Jesus. (John 10:7 – *“I Am the Door of the sheep.”*; John 10:9 – *“I Am the Door: by Me if any man enter in, he shall be saved, and shall go in and out, and find pasture.”*)

We will establish an atmosphere charged with the Blood of Jesus (faith, love, willingness and obedience). You will be changed, as you receive the decrees and releases from Heaven on your behalf. Remember, Yeshua has blotted out the handwriting of opposing ordinances against us, taken them out of the way and nailed them to His cross (Colossians 2:14).

As Heaven rules in your favor, we will seek also the release of the generational blessings that were hindered by the accusations.



## San Jose Global Reformers Hub Procedure For Going Into The Courts of Heaven

Remember, when we refer to the Courts of Heaven, we are speaking of spiritual legalities. We come to answer accusations, offer evidence of repentance and faith, and petitioning the Judge to rule in our favor. We come to get releases of our inheritance, family situations, and legal pardons for our bloodline. It's an awesome experience to activate freedom and deliverance in our own lives, as well as the lives of others.

We are not referring to the Throne of Grace shown in Hebrews 4:16. We can go before His throne of grace in the confident manner of a beloved child heading toward the comfort of a parent or grandparent. We know our Father wants us to come to Him. It is there that we can get mercy and grace whenever we need it. There is no accuser in this atmosphere.

**Accessing the Presence of God** – If you are not familiar with entering into God's presence, practice entering in according to the instruction sheet – *Accessing The Presence of God*.

**Prepare the case beforehand** according to the steps outlined in *Preparing A Case*.

**Bible Scriptures** – Prayerfully read through the scriptures.

**Foundational Principles** – Prayerfully read the *Foundational Principles* documents to increase your understanding.

### On The Day of The Courtroom Ministry

#### What We Do In Preparation For Coming Into The Courts

- Take Communion.
- Take authority over the room – Seal the room according to Psalm 91.
- Come into the courts with worship, thanks and praise.
- Submit to God's authority.

There is no formulaic instruction for what happens in the courts of heaven. That would be a limitation on the Kingdom of Heaven. What we have learned thus far is that Holy Spirit, Jesus and The Father have it all worked out. We have encountered a few different ways that we can enter the courts.

As more and more testimonies are published regarding experiences in the Courts, we begin to get an idea of what it might be like. Some testify of having bypassed all of this and garner amazing experiences with very little preparation. Some testify of going quickly, being heard and getting a quick ruling, no repentance necessary.

Just so you understand, we do not base your experience on the testimony of others. We rejoice in their testimonies, because it gives us the joyous expectation that the Judge will hear your case. The Courts of Heaven are real, and have been in existence a lot longer than any of us have been in the earth. There are various courtrooms and

protocols in the courts, in Heaven just as it is in earth. Some have small claims, some have territorial issues, inheritances to be recovered, and so on.

The consistency in every encounter is going through Yeshua, our Door, being led by Holy Spirit into all truths, and the holy, righteous nature of our Judge. We do not speak to our adversary; we only speak to God. The following steps provide an overview/outline of the Heavenly courtroom experience, designed to give you an idea of what you may encounter. Please review them as such.

1. Ask permission to come into the Courts. We do this by asking that a court room be opened to hear our case. We do not move forward on assumption; we wait until there is a sense of permission granted. If there is an obstruction, we ask what it is so that it can be addressed.
  - a. One example is with regards to our clothing. If we are clothed in filthy garments, they must be changed. We must enter the presence of the Judge clothed in His righteousness. (Zechariah 3:3-7).
2. Another way that we enter the courts is by summons. We are summoned or invited in, and suddenly find ourselves there.

### **Once In The Courtroom**

Present the verdict/breakthrough you are asking for to the Judge.

#### **Dealing With All Accusers/Accusations**

- Ask the Judge to have any accusers that are standing against your verdict to come forward and present their accusations.
- Ask that all acts of past repentance, prayer, intercessions made on behalf of the verdict being sought be read into the record.
- Repent for all areas Holy Spirit reveals the accuser(s) are using to withhold the verdict you are seeking from the Father, the Just Judge.
  - Deal with Self first
  - Mother's Bloodlines
  - Father's Bloodlines
  - Any intercessory function – in the Courts for others
- Apply the Blood of Jesus Christ to cancel and silence every accusation – Revelation 12:10-11.
- If the accuser reveals covenants, contracts or agreements that have been made, repent for them. Then ask that they be nailed to the Cross according to Colossians 2:14.
- Remember to deal with the motive as well as the sin, transgression or iniquity.

- When the process of repentance is fully completed, a sense will come that all the areas the accuser had been using were nullified.
- Present evidence in support of the case – Book of Destiny, pertinent scriptures, generational promises and gifts, prophetic words.
  - Ask that other voices that speak in Heaven on your behalf to speak in support of the verdict.
- See/sense if the accusations have been answered and accuser(s) silenced.
- If more accusations/accusers present themselves, repeat the above procedures until all related to the issue have been dealt with.

### **Asking For The Verdict**

- Then ask The Father for the answer and/or verdict to be released on Earth.

### **Executing The Verdict**

- If the verdict is given, then we switch from our priestly function to kingly function. We execute the verdict.
- Declare and decree all pertinent scriptures, prophecies, words from the Book of Destiny pertinent to the verdict.

### **Binding The Enemy**

- Then, and only then, if led by Holy Spirit, to bind and/or rebuke the enemy who may be withholding the verdict, answer, breakthrough or blessing on earth.
- Be diligent to activate the verdict with any revealed action steps.

### **Leaving The Courts**

- Seal the time in the Courts in the Blood and the Light of the Lord Jesus Christ.
- If the case feels unfinished, we may ask to seal the work accomplished and ask for continuance / adjournment to come back and finish the case.
- Thank God for His wonderful care allowing us to access His perfect justice.
- Reverently ask that we may leave the Courts.
